I) GENERAL INFORMATION REGARDING ADMISSION TO UNIVERSITY HOSTEL

The Hostels are meant primarily for the students of the University Departments run by the University. The application for admission to the hostel must be submitted in the prescribed form, which can be had from the University office. The allocation of the rooms will be made by the Hostel Committee. Rooms shall have to be occupied as allotted by the Hostel Committee and no change of room is allowed. Admission fee of Rs. 25/- per term must be paid along with the application form. The following remaining hostel fees shall have to be paid by the student before occupying the room. In case room is not allotted, admission fees would be refunded provided it is claimed before 31st August of the year.

- 1. Utensil charges Rs.10/- (per term)
- 2. Room rent (single seated) Rs.700/- (per term)
- 3. Water and electrical charges RS.125/- (per term)
- 4. Total hostel fees Rs. 835/- (per term)
- 5. Hostel deposit Rs.300/-

II) HOSTEL MESS

The mess will be run on co-operative basis. Every resident student must be a mess member. They must make payments regularly and strictly and adhere to the rules made for the mess. Any default in this respect on the part of the resident student may lead to the loss of seat in Hostel.

III) FACILITIES AVAILABLE

A Health Centre is available on the campus for consultation and treatment Normally each room will be provided with a table, chair and cot. Prominent daily news papers in Marathi and English are supplied and are kept in the general reading room.

IV) HOSTEL DISCIPLINE RULES

- 1. No functions, celebrations, meetings and organizations of any type shall be conducted without the prior permission of the Rector.
- 2. Students shall have to observe complete discipline inside the Hostel & on the University campus.
- 3. Hostel students are particularly required to maintain regularity in their academic life. Their failure in examinations or irregularity in work may result in the cancellation of their hostel seats from the beginning of the following term.
- 4. The resident student, who wishes to remain absent himself/herself from the class and hostel, on a weekday, must approach the Rector for Such permission.
- 5. No student shall undertake to repair himself any damage to the room, fittings, fixtures of furniture or carry out any alteration therein. He/she should report the repairs to the Rector.
- 6. No wasteful or improper use of water, electricity etc, is allowed.
- 7. Students will be personally held responsible for the damage to the furniture, windows, doors, walls electric fittings etc. and the cost of damage thereof shall be recovered from them.
- 8. Loss of utensils, if any will be recovered from the students on pro-rata basis at the end of every term.
- 9. Students shall have to bring their own electric tube-lights / bulbs of 250 volt-40 watts. mattress, bed-sheets, blankets, mosquito-net, bucket, jar and glass.
- 10. Use of electric bulb of more than 40 watts is strictly prohibited.
- 11. Students are expected to switch off the lights in their rooms every time they go out or before they go to bed.
- 12. No student is allowed to have a guest in the room to stay for the night.
- 13. No student is allowed to play music (Vocal or instrumental) or indoor games in the room.
- 14. Rooms and the premises must be kept scrupulously clean and tidy.
- 15. Students must remain present in their rooms between 11-00 p.m. and 6-00 a.m. (For Ladies hostel 7-00 p.m. to 6-00 a. m.)
- 16. Outsiders are not allowed to enter the rooms without permission of the Rector.
- 17. Every case of illness must be reported to the Medical Officer or Rector immediately

- 18. No meeting shall be convened anywhere on the University premises without the permission of the Vice-Chancellor.
- 19. Every hostel student must possess an identity card bearing the hostel name and the room number in which he/she is staying.
- 20. The University authorities shall have full powers to expel any student from the hostel, if he/she is found undesirable for any other reason to be a resident in the hostel.
- 21. A resident student must leave the hostel and give vacant possession of room to the Rector within three days after the end of each term of university. or board examination, whichever is later. Under no circumstance he/she will allowed to extend his stay in the hostel after that period.
- 22. Disciplinary action will be taken against the student for willful disobedience or defiance of authority, non-observance of hostel rules, mischievous and insolent or immoral behavior, The action may be a fine, expulsion and / or forfeiture of the degree depending upon the nature of the offence.
- 23. Students wishing to discontinue the residence in the hostel for the second term must inform the hostel Rector in writing before the end of the first term. Otherwise, they will have to forfeit deposit and may be charged full rent for the second term.
- 24. The research student must hand over the possession of the room immediately after submission of the thesis. In no case he/she shall be allowed to retain the room for more than one week. If he/she fails to vacate within a week, he/she will be charged Rs.10/- per day.
- 25. No hostel charges, except deposits once paid are refundable. Hostel deposit and mess advance will be refunded to the student, if the application for the refund of deposits is made within one year from the date of completion of the examination or from the date of leaving the hostel.
- 26. A student admitted for Ph.D. shall be allowed to stay in the hostel for a maximum period of three years or till the submission of thesis, whichever is earlier, at the discretion of the University authorities.
- 27. Failed students or students who rejoin after a period of one year are not eligible for hostel seat.
- 28. No parasites are allowed to stay in the hostel. In case of violation, occupant shall have to pay a fine of Rs. 200/-:
- 29. No resident students are allowed to keep the guests in their room. Guests will be accommodated in hostel guest room at the rate Rs. 10/- a day, based (on the availability of the room..
- 30. Students can avail the hostel facility of the University for one P. G. course only.
- 31. Internet connection is made available to the resident students. Any student found misusing the internet facility shall be punished by being expelled from the hostel as well as the University.
- 32. Students availing fellowships/ scholarship / any other financial assistance shall have to pay their HRA as hostel fees.
- 33. Local students will not be ordinarily admitted to the hostel.
- 34. In accordance of Maharashtra ragging prohibition act 1999, those found involved in ragging will be (i) given strong punishment (ii) debarred from College/University department for 5 years and will not be allowed to take admission anywhere for five years (iii) sent 2 years imprisonment and (iv) can be fined up to Rs. 10,000/-
