NOTICE OF ELECTION

In exercise of the power conferred upon me under Sub-section 6(d) of section 14 of the Maharashtra Public Universities Act, 2016 and as provided in Election Statute under official Gazette of Government of Maharashtra dated 29th April, 2017 it is hereby informed by this notification to all the members of the Academic Council that the elections as stated above to the Management Council under Section 30(4)(j) of the Maharashtra Public Universities Act, 2016 shall be held by ballot at the Academic Council meeting to be held on **30th July, 2023** in the Senate hall of this University at Nanded.

The elections shall be held by system of proportional representation by means of the single transferable vote and as prescribed by the statutes.

The seats to be elected are as mentioned in following table.

Election to the Management Council:

30 (4) (j) Two Teachers:

Two members elected by the Academic Council from amongst its members, one of whom shall be from amongst the elected teachers who are members of the council and another shall be a women.

The eligibility conditions for being elected as prescribed in the official Gazette of Government of Maharashtra dated 29th April, 2017 is as follows:



Authority and Section	Eligibility conditions for being elected as member of the Authority
Section 30(4)(j) ELECTED TEACHER MEMBER OF ACADEMIC COUNCIL	(a) Shall possess Ph.D. degree, (b) Shall have at least 15 years aggregate teaching experience, (c) Shall be a recognised Ph.D. Guide under whose supervision, at least two students have been awarded Ph.D. Degree, (d) Shall have authored/co-authored at least two text books/reference books or shall have published at least three research papers in peer reviewed journals as first/corresponding author, (e) Shall have undertaken university examination related work for at least five years in aggregate.

A candidate contesting the election shall submit his/her nomination along with the following documents:

- Self attested copy of Ph.D. Degree.
- Self attested copy of fifteen years teaching Experience Certificate from the Principal/ Registrar (University Teachers)
- Ph.D. degree or Declaration of Result of two students who have completed Ph.D. degree under the supervision of the candidate.
- Self attested copy of first page of at least two text books/reference books or shall have published at least three research papers in peer reviewed journals as first/corresponding author
- Self attested copy of Certificate / Proof regarding having undertaken Examinations related work for at least 5 years.
- Receipt of prescribed nomination fee of Rs.100/- paid to the University office.

The term of office of the elected members shall be as provided under Section 62 of the Maharashtra Public Universities Act, 2016.

Candidates shall submit their nominations for election in prescribed form along with the copies of required documents in person or through a person authorized by him in writing **10th July, 2023 to 14th July, 2023 on working days** at Election Department of this University.

The candidate must fill the nomination form which are available at election department and this university website www.srtmun.ac.in, election portal-2022. The nomination form prescribed fees of Rs. 100/- paid in Account department of this university.

The nomination forms shall contain date, names in full, address and designation, if any, and voter numbers of signatories and of the candidates nominated. The nomination forms shall be dated and signed by to electors entitled to vote.



No person shall be nominated as a candidate for election unless he/she signifies consent under his/her signature and date on the nomination paper. No person shall either propose or Second his own nominations.

Incomplete nomination form or the nomination form which does not comply with all the requirements as mentioned above and as provided in the Statute shall be invalid and shall be rejected for future detailed information, please refer election and eligibility statutes which are available at university election portal-2022 of www.srtmun.ac.in. The provisions in Act and Statute are final and binding.

It shall be open to the candidate to withdraw his/her candidature form the election, provided that the candidate submits an application in person or through person authorized by him in writing for withdrawal **on 24th July, 2023 to 25th July, 2023 before 05.00 p.m.** signed by the candidate and duly attested by the Principal/Director of Recognized Institute/ Director of Campus Schools to the undersigned. The list of the candidates validly nominated for the election will be notified on the notice board of the University office and University website www.srtmun.ac.in soon after the expiry of the date of withdrawal of nominations.

In the case of election, of contesting post the **ballot box will be kept** open for voting **between 12.30 p.m. to 01.30 p.m. on Sunday, 30th July, 2023.** The members coming after the specified time will not receive voting papers.

The counting of the said election will begin after voting is over on the same day.
