## Instructions for Revaluation/Verification & Photocopy

Submission of applications under G.R.M. system for the examinations held in Winter-2022 for **law courses (B.A.L.L.B. First year and B.A.L.L.B. Third year / L.L.B. First year)**

1. The last date for submission of Recounting Forms for Verification of answer books along with Recounting Fees ( Rs. 75/- per answer books), photo copy of answer book fees (Rs. 250/- per answer book) & Direct Revaluation fees (Rs. 350/- per answer book) by student to college is **8.05.2023** and date of Demand draft or E-payment is **09.05.2023. D.D.** of the nationalised bank is to be drawn in favour of **Finance and Accounts Officer, S.R.T.M. University, Nanded**

3. **Direct revaluation** may be done in maximum two papers in each semester; while there is no sealing for photocopies and verification of answer books. However, no candidate is allowed for both photocopy and direct revaluation simultaneously.
4. **In Verification/recounting** obtained marks are only counted. Students will be provided photocopies of answer book under application for photocopies/Xerox copies and in case of direct revaluation the answer book will be reassessed.
5. Candidates indulged in malpractice are not allowed for verification, photocopies or direct revaluation under GRM system.
6. The last date for submission of recounting forms, photo copies of answer book & Direct Revaluation forms by college to University with necessary fees by D.D. or e-payment, statement, proposal in **two copies** – original & Xerox set and scanning of revaluation forms, preferably jpg /pdf file/soft copies and in the **excel sheet** is **10.05.2023**.
