या परिपत्रकान्वये सर्व संबंधितांना कळविण्यात येते की, दिनांक ८ जून २०१९ रोजी संपन्न झालेल्या ४४व्या मा. विद्या परिषद बैठकीतील ऐनवेळचा विषय क्र.१०/४४-२०१९ च्या ठरावानुसार Ordinance for SWAYAM-NPTEL-Other MOOC Courses Credit Transfer under CBCS बाबत मा. कुलगुरू महोदयांच्या आदेशान्वये गठित CBCS-Credit Transfer Committee यांनी शिफारस केलेल्या खालील मुद्यांबाबतचा अहवालास मान्यता देण्यात आली असून, तो शैक्षणिक वर्ष २०१९-२० पासून लागू करण्यात येत आहे.

- १) मा. अधिष्ठाता मंडळाने मान्य केलेले विषयच असावेत.
- २) महाविद्यालयाने तो विषय सुरू करण्यापूर्वी त्याचा प्रस्ताव अभ्यासमंडळाकडे पाठवावा तसेच त्यात काही त्रुटी असल्यास त्याची सर्वस्वी जबाबदारी महाविद्यालयाची राहिल.
- ३) विद्यापीठ अनुदान आयोगामार्फत चालत असलेल्या विषयांची माहिती महाविद्यालयांनी शैक्षणिक (१-अभ्यासमंडळ) विभाग आणि शैक्षणिक (३-संलग्नीकरण) विभाग यांना सादर करावी.

Ordinance for SWAYAM/NPTEL/OTHER MOOC Course Credit Transfer under CBCS-2019

1. Preamble:

Whereas UGC has asked to make amendments required in ordinances, rules, regulations to incorporate UGC (Credit framework for online learning courses through SWAYAM) regulation, 2016 vide its para 7 and Hon'ble Vice-Chancellor, SRTM University, Nanded in exercise of the powers conferred on him, has nominated CBCS Credit transfer committee to draft the Ordinance.

The duration of the said committee will be for a period of three years. The committee comprises of the following members:

The committee after thorough deliberations makes the following recommendations for the effective implementation of UGC (Credit Framework for Online Learning Courses through SWAYAM) Regulation, 2016:

2. Short title, Application and Commencement:

- i. This ordinance shall be called the **SRTMUN Ordinance for SWAYAM/NPTEL/OTHER MOOC Course Credit Transfer under CBCS-2019**.
- ii. It shall apply to all campus schools, sub-centres, model Degree College and affiliated colleges of this university.
- iii. It shall further apply to the transfer of credits of such students who are enrolled as regular student.
- iv. It shall come into force from the academic year 2019-2020.
- v. It will be implemented in institutions having SWAYAM-NPTEL Local Chapters.

3. Definitions:

- i. 'Course' shall mean a paper which is taught for at least one semester as a part of a subject.
- ii. 'MOOCs': Massive Open Online Courses (MOOCs) are such online courses which are developed and made available on the SWAYAM platform of Government of India.
- iii. 'MOOCs Guidelines' shall mean guidelines on online learning issued by the MHRD vide its orders dated 11th March 2016 and subsequent addendums issued by the MHRD.

4. Opting and Facilitating Online learning courses:

- i. The online learning courses available on the SWAYAM Platform will be considered for credit transfer.
- ii. The SPOC of the Local Chapter/Director/Principal in June and November every year shall notify the list of the online learning courses eligible for credit transfer in the forthcoming Semester.
- iii. The university/college has to take care that there should not be any overlapping of SWAYAM-NPTEL MOOC exams with that of university/college mid-semester/internal exam and end-semester/external exam.
- iv. Any candidate can be permitted to opt for only up to 20% of the total courses being offered in a particular program in a semester through the online learning courses provided through SWAYAM platform.
- v. Desirous students opting for an online course would be required to register for the MOOCs for that course/paper through SWAYAM-NPTEL Local Chapter and it will be mandatory for her/him to share necessary information with the college/institute and potential employer.
- vi. While allowing the online learning courses offered by SWAYAM, it shall be ensured that the physical facilities like laboratories, computer facilities, library etc, essential for pursuing the courses shall be made available free and in adequate measure by the concerned institution.
- vii. The concerned institution must designate a Single Point of Contact (SPOC), Mentor/facilitator to guide the students throughout the course and to facilitate/conduct the lab/practical sessions/examinations.

5. Credit mobility of MOOCs:

- i. The university shall give the equivalent credit weightage to the students for the credits earned through online learning courses through SWAYAM platform in the credit plan of the program.
- ii. Credit transfer policy will be applicable to -
 - a) All UG and PG programmes offered by the university that follow CBCS pattern.
 - b) Capability Enhancement courses, Skill Enhancement Courses, Elective courses, Elective Courses (Intra/ Inter).
- iii. Core courses will be excluded until further guidelines by the UGC.
- iv. For Ph.D. programmes in all disciplines credit transfer facility through SWAYAM MOOCs should be encouraged by research supervisors for internal assessment. Such courses ought to be domain/subject specific. The PhD students are required to opt for MOOCs through the SWAYAM Local Chapter of the Research Centre only.

6. Procedure for credit transfer:

The procedure for transferring credits from SWAYAM-NPTEL MOOC courses is as follows:

- i. During the current semester, the candidate while filling up her/his exam form will have to submit an undertaking for credit transfer forwarded through SPOC and Director of the School/Principal of the college. In this case the student need not appear for university exam for the exempted course.
- ii. The Local chapter (school/college) will intimate the exam section about the completion of a course by a letter from the SPOC and the Director of the School/Principal of the college

along with the certificates of completion and the list of students, who have passed MOOC courses in the current semester.

- iii. The student qualifying SWAYAM-NPTEL MOOC course will be given equivalent credit transfer. For example, 4 week (1 credit) course, 6/8 week (2 credit), 12 week (3 credit), 15/16 week (4 credit) or equivalent credits.
- iv. If a 4 credit course is not available as per the choice of the student then he can opt for a 3 credit course that is available and 1 credit will have to be acquired through continuous internal evaluation through a mentor.
- v. If a 3 credit course is not available as per the choice of the student then he can opt for a 2 credit course that is available and 1 credit will have to be acquired through continuous internal evaluation through a mentor.
- vi. Students who have qualified in the proctored examination conducted by the SWAYAM - NPTEL and apply for credit transfer as specified are exempted from appearing in the continuous and semester end evaluations (internal as well as external for the specified equivalent credit course only) conducted by the university.
- vii. If a student fails in the opted SWAYAM course, s/he will have two choices: he can opt for another SWAYAM course of equivalent credit in the next semester, or he can revert to the traditional exempted course offered by the university. Such student's claim to attend classes for the said course and undergo continuous assessment will remain unaffected. Such a student will be able to undertake the traditional course under the mentor in the immediate succeeding semester so as to avoid any loss of semester.
- viii. If a student opts for additional MOOC course above 20%, it will be considered as add-on credit and will be reflected on the marks sheet but will not be taken into account for tabulating CGPA.
- ix. In case of delay in SWAYAM results, the university will re-issue the marks sheet for such students.

7. Anticipatory Measures:

- i. The existing university level CBCS credit transfer committee shall resolve any issues that may arise in the implementation of this ordinance from time to time.
- ii. The university shall review its credit transfer policy in the light of periodic changes brought by UGC, SWAYAM, NPTEL and state government through the existing university level CBCS credit transfer committee.
