



National Road Safety Week – 2026

Dear Sir,

1. As very soon we shall be celebrating 'National Road Safety Week' from 11 to 17 January 2026, I request to instruct all colleges/ institutes affiliated with your university to run this important campaign very effectively. As road traffic accidents are a major threat to the lives of our young generation, kindly consider my following request:

(a) Almost all institutes have deployed private security guards at their gates, all these guards should not allow the entry of any vehicle of staff member or student inside the main gate if the user is without a helmet/ seatbelt. This should be routine practice, not limited to this safety week.

(b) Reel making competition may be organized wherein students make reels on importance of wearing helmet/ seatbelt, driving vehicles on low-beam at night, no honking in silence zones, not modifying the silencer of bullets, and protection for good Samaritan in India.

(c) It is disturbing to learn that many staff members are using vehicles without a valid driving license, helmet, seat belt. I request to implement a mechanism wherein the security guards will report such violations to the Principal/ Registrar and the concerned violators will be penalized.

2. Since universities/ colleges are high-density hubs for young adults who are transitioning to independent mobility, I believe the primary societal responsibility for embedding a culture of ethical and safe road use must be shouldered by these institutions.
